### GENERAL INFORMATION

NPK solution fertilizer 4-10-10 (NPK Ratio: 1-2.5-2.5) is a clear liquid fertilizer containing 4% nitrogen, 10% phosphate and 10% potassium. The phosphate in 4-10-10 is composed of 60% to 70% in a polyphosphate form while the balance is in the form of orthophosphates. The polyphosphates in 4-10-10 extends the availability of fertilizer when applied in high pH soil conditions as well as aiding in sequestering needed trace elements for active plant growth. This polycontent in 4-10-10 also extends the storage life so product may be stored for later use. Unlike most granular phosphate material, liquid 4-10-10 is 100% water soluble.

NPK fertilizers do not move readily in soil. Placing the band of product near developing seedling roots of annual crops is most effective. Placement below the depth of seeding may improve availability under dry conditions because the fertilizer is in a moist part of the root zone for a longer period of time than with seed row placement. Broadcast-incorporated applications are less effective than when fertilizer is banded with or near the seed of annual crops.

Conventional agricultural equipment should be used for application. Methods of application: broadcast, side dress and banding. This product is compatible with most liquid fertilizer/pesticide mixes at manufacturers' specified label rates. However, it is recommended that a "jar test" be performed prior to actual application to insure compatibility.

### FIRST AID
